One-page handwritten document, in printed format with coat of arms in the lower left part; it shows the appointment granted by José de San Martín, as Protector of Peru, in favor of José María Valdés as Captain of the First Cavalry Company. The date is Lima, 6 October 1821. It has a handwritten page number of "34", also a seal of the *Archivo Histórico del Ministerio de Hacienda* (Historical Archive of the Ministry of Finance), and a signature in ink: "O.L 28, b - 2". The page is in fair state of preservation, with fold marks. This is an original document (not a copy or testimony), with the signature of the grantor and handwritten in italics.

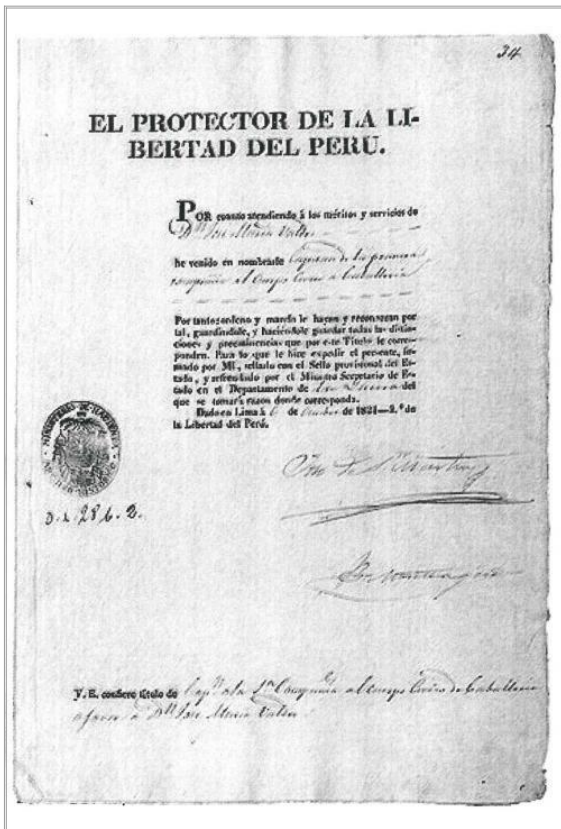
